GRAPHS REGARDING IMPORT AND EXPORT OF DAIRY PRODUCTS BY SOUTH AFRICA DURING THE YEARS 2014 TO 2021

The total figures in respect of import and export of dairy products by South Africa in 2021, were recently received from SARS. Attached are graphs, as prepared by the Office of SAMPRO and based on the information from SARS, which provides macro pictures of import and export of each of the six different types of dairy products during 2021 and during each of the previous seven years.

As is well-known, in each of the six types of dairy products, products of significantly different specifications and prices are classified. For example, the customs tariff provision for cheese, contains separate provisions for fresh cheese, grated or powder cheese, processed cheese, blue veined cheese and "other cheese". The provision for "other cheese" includes separate provisions for, amongst other, gouda and cheddar cheese.
