#### **Trade Relations with Vietnam**

The Vietnamese Ambassador, Mr. Hoang Sy Cuong invited a FruitSA business delegation to participate in the Embassy's recent event to celebrate 30 years of diplomatic relations between Vietnam and South Africa. Our Chief Operating Officer participated in a joint meeting with the Vice-President of State of Vietnam, during which the FPEF introduced information on the successful export of deciduous fruits from South Africa to Vietnam. The finalisation and signature of the protocol for the export of citrus to Vietnam was cited as a major priority for South African fresh product trade and shared.



This event provided an exclusive opportunity for the two countries' business communities to match up, and also a chance to connect directly with Vietnam governmental authorities. The FPEF COO used the opportunity and met with Mr Viêt Chau, Deputy Director General for the Vietnamese International Cooperation Department of the Ministry of Agriculture and Rural Development. The conversation stipulated the need to fast track market access for fruit and future negotiations for a Free-Trade-Agreements (FTA) with Vietnam.

## **LOGISTICS & OPERATIONS**

Mop up operations and damage assessment has started in the Western Cape after a weekend of widespread flooding, high winds, and road closures. Cape Town Container Terminal lost 67 hours due to wind delays and 10 stacking areas were impacted by containers blown over, tipped or stacks moving. Producers report that they observed infrastructure damage but that vines for the most part are unaffected. Over the next week or two the picture will become clearer.

The City of Cape Town together with stakeholders such as trucking organizations and the Paarden Eiland community gathered to discuss the need for the trucking fraternity ahead of the TNPA permanent staging area that is currently slated for 2026 completion. Input was sought if the facility should be a staging area and / or a truck stop. While drilling down on requirements, possible sites were mentioned next to the R27 where trucks currently stop but the surface as well as the land next to the canal close to the M5 interchange need construction work to be done.

#### **FPEF Transformation Webinar**

The FPEF held its 7<sup>th</sup> annual transformation webinar on the 19<sup>th</sup> of September. The goal of the webinar is to inspire and equip business leaders to facilitate proactive and effective transformation in their businesses. This year's speakers were Mr Jonathan Goldberg and Mr Athol Trollip. Jonathan is the Chairman of Global Business Solutions and has been a business leader in the changing labour law landscape over the past twenty years. Athol is a well-known politician, motivational speaker and ex-farmer who is currently the Provincial chairperson of ActionSA in the Eastern Cape.



and major business interruptions.





Athol reminded us of the devastating effect of the 1913 Native Land Act in South Africa, which lead to evictions, expropriation, relocation and segregation and is responsible for much of the trouble which blights the transformation of South Africas agriculture sector. He believes we can however overcome this legacy with a lot of time and effort from both the government and private sector. He believes a key blockage that the government needs to address is the provision of secure land tenure to black farmers. He shared some of his experiences during the time he was contracted to support SAFPRO's exemplary support of 13 black citrus farmers in the Eastern Cape and 2 packhouses serving the growers (SAFPRO is a FPEF member company and the CEO, Mark Jensen is Chairman of the FPEF Board). They managed to secure funding to expunge the growers debt, which was crippeling them, secured one years' produciton grant finance and assisted with much needed technical knowledge. Athol also reminded us that industry bodies such as the FPEF have a vital role to play in lobbying the

government to address key issues facing the industry.
