Port Matters

FPEF together with SATI and HORTGRO will meet with the National Transnet Management team today to discuss season readiness and knowing that the liner services will remain unchanged, the focus is wind recovery processes and communication with the industry. We have experienced wind this week with both Durban and Cape Town suffering delays, we have used this opportunity to observe the ports responded and will build on this for the season but for the time being vessels at anchor has increased.

PPECB has appointed 6 new staff members and they are monitoring the EU citrus developments in the event that more inspectors are required for next year's citrus season.

China

China places millions under lockdown, striking a further economic blow. Hebei province and Shenzhen, a tech center, are among the regions subject to new COVID limitations. China has locked down millions of people, giving the economy a further blow as it attempts to recover from almost three years of "zero COVID" policies.

In Hebei, the province bordering Beijing, authorities on Tuesday ordered almost four million people to remain inside until the end of the week as they worked to contain an outbreak of COVID-19. (Source: Aljezera)

PROGRAMME: PHI (POST-HARVEST INNOVATION) PROGRAMME

The Department of Science and Innovation (DSI) has only recently confirmed their funding commitment towards the next Post-Harvest Innovation Programme (PHI) funding phase, which is the 5th round of the Programme. The DSI is currently finalising the funding contract with the FPEF. The total Programme value is **R24 190 561** (excluding VAT) of which **R17 788 468** (excluding VAT) is available for Research and Development. An official 'Call for Proposals' will be published in selected Newspapers upon the official signing of the aforementioned funding contract. The closing date for individual researchers' funding proposals is **19 September 2022.** All proposals must have prior industry approval before submission to the FPEF.
