PORT OF CAPE TOWN

The turnaround strategy which Transnet Port Terminals (TPT) implemented has proven successful for more fluid operations inside the terminal. Rubber Tyre Gantry (RTG) availability increased with between 18 and 20 RTG's available to handle containers inside the terminal. Straddle carrier availability remained stable with between 5 and 7 straddle carriers effectively used in the terminal, for the past couple of weeks. Unfortunately, weather delays occurred with the port experiencing strong winds and fog that adversely impacted operations. Weather delays amounted to 37.15 hours lost in the past week.



TRANSFORMATION - FPEF EMERGING EXPORTER SUPPORT PROGRAMME

In February this year, the FPEF's new emerging exporter support programme was launched with the selection of four promising, aspiring exporters, following a comprehensive selection process. Under the programme, the aspiring exporters will receive a combination of mentorship, coaching, practical support (access to fruit, markets, post-harvest technical guidance, logistics guidance, risk management etc.) and where relevant, be provided with opportunities to gain practical exposure and experience in the form of short-term placements and/or job shadowing.

All four exporters now have a few support opportunities lined up and/or have already utilised support opportunities provided as follows:

RDJ Agri Exports (Robert and Joel Andrews and Dylan Moodaley) - Attended Wesgro Middle East Webinar: Unlocking Business Opportunities in the UAE, had first mentorship meeting in March with Catherine Smuts of De Keur and Joel and Robert will attend the FPEF's online TOC value chain training starting in April.

Spillion Group (**Ikarabele Motshwane**) - Flew to PE on the 6th of April to spend a couple of weeks with SAFPRO gaining hands on exposure to the industry.

Bunang (Morongwa Mothiba) - Attended SEDA's SheTrades Awareness webinar in March, she will travel to Cape Town end of April to spend a week being mentored by Gerald Gant at Capespan and gaining exposure to the industry and she will attend the FPEF's online TOC value chain training starting in April.

Liora Capital (Yoza Jekwa and Ludwe Ndingi) – Have scheduled a first mentorship session with the Capefive team and Ludwe and their new admin staff member will attend the FPEF's online TOC value chain training starting in April.

In addition to the above **Gerald Gant** will meet with the rest of the exporters in May and **Prophet** have offered to provide a Prophet QX support package when the exporters are export ready.

Luke Govender of the dtic, who serves on the FPEF board, provided the following feedback and encouragement:
